Ref: Former government agent notification on conduct aiding terrorist attacks on U.S.

To President Obama:

The purpose of this letter, from a former federal agent, is to provide the White House with information and to put you on notice of existing conditions that I have discovered over the years that among other consequences were a continuing series of preventable terrorist attacks on U.S. targets.

This information is based upon my years as a federal airline safety inspector-investigator and many years documenting problems, including corruption, involving key people in the federal government. I have been so concerned about the continuing great harm arising from this conduct that I have written a number of not-for-profit books and have taken other steps seeking to expose and circumvent the culture of cover-ups in the United States.

You expressed anger over the intelligence lapses that made possible the terrorist attack on Northwest Airlines Flight 253 from Amsterdam to Detroit. These lapses are significant, but fall far short of the documented corruption that made possible a series of prior terrorist successes. All of these serious problems have been covered up, and their continuation will result in a continuing series of successful terrorist attacks.

The misconduct of various people and groups that made possible the easy successes on 9/11 provides the most documented example of why 3,000 people perished on that day and then led to the U.S. starting a war with Afghanistan and Iraq while people inside the United States had a far greater blame for making possible the successful hijackings.

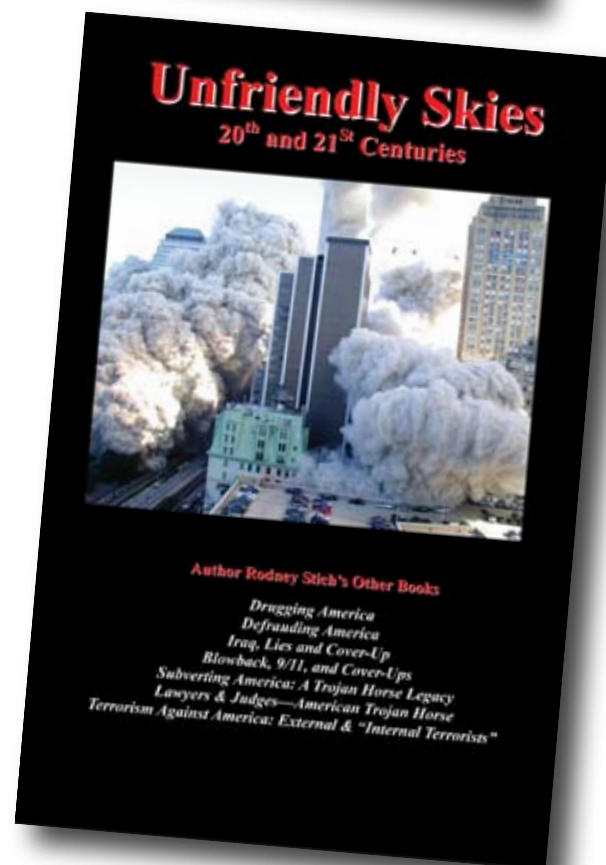
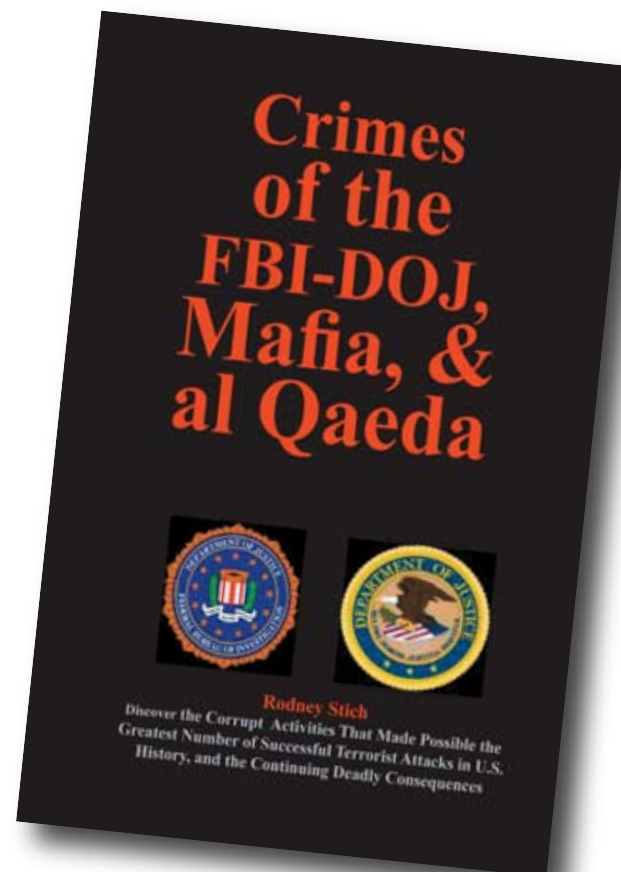
Most Complete Insider's View of Why Terrorist Attacks Against U.S. Have Succeeded
