






# Shocking Comparison Between Charges Against Martha Stewart and Conspiracy and Obstruction Of Justice by Justice Department Prosecutors

The following are a few highlights of federal offenses perpetrated by the same Justice Department that charged Martha Stewart with conspiracy and obstructing justice:

- ◆ Pattern of documented obstruction of justice by Justice Department personnel blocking federal agents from reporting criminal activities in government offices and in covert operations that they discovered in their official positions. Some of the corrupt activities being covered up include, for instance, in the government's aviation safety and intelligence offices that created the conditions enabling terrorists to seize four airliners on 9-11; drug smuggling by CIA and other covert operations; massive corruption in the bankruptcy courts; and many other areas adversely affecting national security.
- ◆ To block reports of corruption in government offices, Justice Department prosecutors and federal judges charged a former federal agent with criminal contempt of court for attempting to report these federal crimes. Ironical relationship to the events of 9-11. That former agent sought to report to a federal court corrupt activities, as required to be reported by the federal crime reporting statute, Title 18 U.S.C. § 4.
- ◆ Pre and Post 9-11 obstruction of justice by Justice Department lawyers and federal judges, who repeatedly blocked attempts to report the criminal activities.
- ◆ The obstruction of justice tactics by Justice Department lawyers and federal judges include (a) repeatedly blocking the reports; (b) issuing unlawful and unconstitutional orders permanently barring the federal agent from federal court so as to block his reports and deny to him the federal defenses against massive civil rights violations taken to silence him; (c) corruptly seizing his \$10 million in assets that funded his exposure activities; and much more.
- ◆ Catastrophic effects of the corruption, the obstruction of justice, and the retaliation is described in various federal filings, including those filed in the same U.S. district and appellate courts where Justice Department lawyers charged Martha Stewart with obstructing justice and where most of the 9-11 lawsuits have been filed. If you think this culture doesn't affect you and the nation, then dream on!
