Ref: Evidence proving 50 years of CIA drug trafficking into the United States, and the widespread cover-up of these subversive and criminal activities.

Dear Sir:

You, CIA Inspector General Fred Hitz, and your agency, have recently said to the American people that the CIA had not conducted, aided and abetted, or knew, of CIA involvement in drug trafficking into the United States. Under Title 18 U.S.C. Section 1001, and other criminal statutes relating to cover-ups, obstruction of justice, misprision of felonies, these lies are criminal offenses.

The offenses are made immensely worse because the lying permits the continued drugging of America, its people, and corruption of its institutions. The other criminal activities associated with the CIA (and DEA and military) drugging of America, and their cover-ups, could very probably bring about the downfall of the United States.

There is overwhelming evidence supporting the fact that the CIA, either directly or through its hundreds of agents, operatives, and fronts, have for the past 50 years engaged in drug smuggling, and that it is continuing to this date. This drug trafficking, and other CIA-related crimes, continues because of the criminal aiding and abetting, cover-ups, obstruction of justice, misprision of felonies, by others in and out of government. These include, particularly employees in the U.S. Department of Justice, federal judges and Justices, many members of Congress, much of the mainstream media, and other government entities, including various covert agencies, the State Department, National Security Council and National Security Agency. These statements are supported by the facts and documents found in the third edition of Defrauding America.

First Discovery As Airline Captain for Japan Airlines

I first discovered this CIA drug trafficking 50 years ago while a captain flying for Japan Airlines out of Tokyo and also flying out of Middle East countries, in the 1950s. Pilots with whom I was in frequent contact described to me the drugs they were hauling for CIA-related companies. This knowledge continued to be conveyed to me by pilots to this very day.

In addition, during the past ten years, I have become friends with many other sources who described to me, and provided me with evidence, of CIA drug trafficking. Enclosed with this letter is a codified list of over two dozen present and former government agents, and others, who:

- Discovered the CIA-related drug trafficking as part of their government activities. They include former FBI agents, former and present police and vice-squad officers, among others.
- Were closely related to the drug trafficking while acting as CIA agents, operatives, or fronts. They include the former head of a covert CIA airline; the former head of a covert CIA financial operation; pilots who flew drugs in planes provided by the CIA and DEA and who hauled the drugs under orders of their CIA and DEA handlers.
- Mafia family member who described the activities of her father who worked simultaneously for organized crime in the New York and Chicago area and the CIA.
- My discovery of CIA drug trafficking during the past 50 years, starting in the 1950s as an airline captain flying for Japan Airlines out of Tokyo and as captain for an airline operating out of Beirut. These reports, from pilots flying the drugs for Air America and other covert CIA airlines, continued for the next 50 years. Further, during thousands of hours of questioning, often deposition-like, of covert agency personnel, drug traffickers, and pilots, the CIA drug trafficking was clearly described.
- My highly detailed and documented third edition of *Defrauding America* contains 753 pages of detailed and documented proof that the CIA, DEA, and military, have engaged in drug smuggling for years. Further, that these criminal and subversive acts were aided and abetted by people in control of the nation's checks and balances, including Justice Department employees, federal judges and Supreme Court Justices, members of Congress, much of the broadcast and print media. I have also produced evidence of the government corruption when I acted as a self-appointed independent prosecutor in the FAA, producing 4000 pages of transcript; numerous federal court filings detailing and documenting the government corruption; other government documents; and a great amount of other supporting evidence.

My Credentials

I was trained as and acted as a federal investigator for many years. My motives during the past 30 years in exposing corruption by government personnel have been to provide evidence of the criminal and subversive activities to people with legal responsibilities to act, and to bring a halt to the resulting harm inflicted upon innocent people. I was initially motivated to take on this David versus Goliath battle when, as a former federal investigator, I discovered and documented patterns of corruption within the FAA that caused or allowed to occur a series of brutal airline crashes. I have documented this relationship while a federal investigator. The felony cover-ups of these criminal activities by officials in the NTSB and various divisions of the Department of Justice caused me to discover government corruption in other areas, including the CIA.

Many of these findings are documented in FAA records, federal court filings, other documents, and in the third edition of *Unfriendly Skies* and the third edition of *Defrauding America*.

At this time the corruption is so endemic that a letter such as this will not pry open the lid on this cancerous growth. The simplistic knowledge by the American public of government misconduct, the low level of public outrage, the brain-dead nature of many Americans, have insured that the government corruption will escalate.

This letter and the enclosed copy of *Defrauding America* (3rd edition) and the codified list of government agents willing to testify about the CIA drug trafficking and those who aid and abet it, are submitted to show that you were provided with sufficient information to where you had a responsibility to allow these people to present evidence at an open and meaningful hearing.
