Ref: Extension to Court of Appeals of due process denial and obstruction of justice

To Judge Walker:

To make a record, the following facts are brought to your attention:

- Judges in the U.S. Court of Appeals, 2nd Circuit, are continuing the documented pattern of obstructing justice and the juxtapositioned due process violations seeking relief from the efforts to halt my exposure of criminal activities against the United States.
- Quick background. I submitted for filing an appellant's brief that was received by your court on January 7, 2004. My Notice of Appeal was filed in the U.S. Court of Appeals and a scheduling order was dated December 11, 2003, docket number 03-6244. The scheduling order provided that Appellant's Brief be filed no later than January 12, 2004, which I submitting for filing in your court on January 7, 2004.
- Today, on January 21, 2004, I checked by telephone with the clerk of the court of appeals to determine why I had not received a file-stamped copy of the appellant's brief. I was told that the brief had not been filed, that pro se briefs are not filed when received, and that the person responsible for such filing was not available. Briefs filed by lawyers, however, are filed when received, raising a due process violation—among many others.
- The appellant's brief—that is being blocked from being filed—raised important matters affecting national security, including corrupt and criminal activities that I, a former key federal aviation safety agent, initially discovered as part of my official duties. Among the catastrophic consequences caused or enabled to occur by these federal crimes are a series of aviation disasters—the latest and most publicized being the hijackings of four airliners on September 11, 2001. The conditions that allowed these latest consequences to occur were the direct consequence of the corruption that I and other federal agents had discovered. The continued block to reporting these matters—being reported to federal judges under the federal crime reporting statute (18 U.S.C. § 4)—continues, as before, the catastrophic consequences to the United States that had occurred in the past.
- Among the people implicated in the coverups have been a CIA-front law firm and its lawyers, and federal judges, who's various unlawful, unconstitutional, and felony tactics made some of these resulting consequences to occur. In an apparent effort to protect these people, the filings of my complaints have been repeatedly blocked through violations of criminal and civil due process rights.
- The most immediate prior example of this judicial obstruction of justice and due process violation occurred in the U.S. district court, Southern District of New York. My complaint—seeking to report these criminal activities, and seeking relief from the massive civil rights violations that occurred while seeking to halt my exposure activities, was delayed from being filed after being received by

the court, for 13 months. This blatant obstruction of justice and contempt for civil rights, was then compounded by spending weeks preparing a five-page dismissal order that was filed simultaneous with the delayed filing of the Complaint. Now, your court is continuing the process.

- That appellant's brief, received by your court on January 7, 2004, and being blocked from being filed, is on the Internet where it is being viewed by thousands of people. Questions are being asked of me about the status of the case. I would like to have your response to why the filing in your court—which seeks to report federal crimes that played key roles in the events of 9-11—is being blocked, and why federal defenses against the massive federal offenses against me to silence me are being denied to me in your court.
