Ref: Request for copy of report prepared by former INS agent Rumaldo Solis, describing involvement of U.S. agents in major Mexican drug smuggling operation, the murder of a Mexican national in Mexico by a DEA agent, and the cover-up of these crimes by the U.S. Department of Justice.

Dear Ms. Reno:

This is a request for copy of the report prepared by at that time INS Rumaldo Solis, at the Port Hidalgo Port of Entry in Texas, that has since been criminally removed from government files, that revealed the following facts:

- An agent of the U.S. government (Immigration & Naturalization Service), Rumaldo Solis, filed a written report at his Hidalgo Port of Entry office, revealing a major drug trafficking operation at a mountainous airstrip in Mexico near Los Mochis, coordinated by an agent of the U.S. Drug Enforcement Administration. That agent is now based in Arizona.
- The DEA agent murdered a Mexican national at that airstrip when the cargo handler discovered the identity of the U.S. government agent.
- The subsequent murder of a Mexican journalist in Mexico, shortly after he started investigating these matters.
- Agents of several U.S. government agencies aided and abetted these crimes against Mexico, covered up for them, and then retaliated against Rumaldo Solis, the INS agent who filed the report that was then hidden or destroyed. These agents were from the U.S. Department of Justice, Immigration and Naturalization Service, Drug Enforcement Administration, U.S. attorney.
- The drug smuggling operation involving major segments of the U.S. government were also directed against the people of the United States, a fact that has been proven by the evidence I have been provided by several dozen former federal agents and operatives.
- Felony cover-ups and obstruction of justice by federal officials at the local and Washington levels.

The murder and drug trafficking, implicating agents of the U.S. government, are in character with what I, a former federal agent, and a coalition of several dozen U.S. agents and deep-cover operatives have discovered during the past 10 years. The cover-ups, the obstruction of justice, the continuation of the criminal activities, are documented standard operating procedures by people holding key positions in the government of the United States.

The murder of a Mexican national, on Mexican territory, by an agent of the U.S. government, to cover up for a criminal drug trafficking operation conducted by a U.S. agent on Mexican soil, has serious implications for Mexico and its people.

The criminal and subversive drugging of America by CIA elements is nothing new. I first discovered it 50 years ago while flying captain for Japan Airlines out of Tokyo and also out of the Middle East. For the last ten years I have become friends with over two dozen present and former government agents who also either discovered the drug trafficking or were part of it. These people include heads of CIA airlines and CIA financial institutions.

Compounding this form of criminal attacks upon the United States are the many other forms of corruption that I and my group discovered, and the aiding and abetting of these crimes by people in control of the U.S. Department of Justice, members of Congress, federal judges, and much of the broadcast and print media.

My Credibility:

I am a former inspector and investigator in the government of the United States, who discovered during the past 30 years patterns of documented corrupt practices involving federal officials in all three branches of government. Over two dozen government agents have provided me with additional court-admissible evidence during the past ten years. I am also a former airline captain who has turned activist against government corruption because of what I discovered initially while an FAA inspector that played key roles in a number of specific airline disasters. During the last ten years I have become the focal point for several dozen present and former government agents and deep-cover operatives, including agents of the FBI, CIA, ONI, DEA, INS, and others. As a block, we have sufficient court-admissible evidence to prove patterns of corruption in government that are undermining the government and inflicting great harm upon many innocent people.

Part of this government corruption, and the well-orchestrated cover-up and obstruction of justice, is detailed and documented in the books, *Defrauding America* and *Unfriendly Skies*, and referred to in the Internet web sites, <http://www.defraudingamerica.com>; <http://www.ciadrugs.com>; and <http://www.unfriendlyskies.com>.

With this letter I put one more federal official on notice of criminal and subversive activities against the United States that I and a group of present and former government agents discovered, and for which most of us suffered some form of severe retaliation to silence or discredit us. Under federal crime-reporting statute Title 18 USC Section 4, it is a federal offense for anyone, knowing of a federal crime, not to promptly report it to a federal judge or other federal official. Therefore, this letter serves to fulfill that crime-reporting requirement insofar as one small area of criminal activities is concerned. Because of the nature of this section of criminal activities that I and my many government sources have discovered, and because of the international implications, the usual Justice Department cover-up (and judicial cover-up) must be done with greater risk of subsequent exposure.

Obviously, you aren't going to allow me or anyone else to gain access to that report. It could pry open the lid on one or more of the major patterns of criminal activities against the United States that are perpetrated by and with the help of many federal personnel.

In time, this letter may appear on one of my web sites that are read throughout the world.
