Ref: Explanation for refusing to allow legal filing seeking to report criminal activities under 18 U.S.C. § 4, including federal crimes related to terrorist hijackings of September 11, 2001.

Judge Kollar-Kotelly,

This letter, appearing on an Internet site, seeks your explanation for refusing to allow my federal filing to be filed which attempted to report corrupt and criminal activities that made possible the success of 19 hijackers seizing four airliners on September 11, 2001. These are documented federal crimes that I initially discovered while a federal air safety agent assigned the responsibility to correct the conditions resulting in the largest numbers of airline crashes in the nation's history. Obviously, I am qualified to make such determination. By your conduct in blocking that filing, my evaluation of your conduct is as follows:

- Blocked the reporting of criminal activities to a federal court which you must received under your administrative responsibilities as provided by federal crime reporting statute, Title 18 U.S.C. § 4. On pages 2 and 3 of the submitted filing are the words relating to the attempt to report criminal activities that I, a former federal air safety agent, and a group of other government agents,<sup>1</sup> sought to report to federal courts, under the federal crime reporting statute, Title 18 U.S.C. § 4. These criminal activities were first discovered by Plaintiff while he held a key federal air safety inspector position, and then greatly expanded over the years through further direct discoveries and then from information and documentation provided to Plaintiff by a group of other government agents.
- On page four of the attempted filing is a list of my background and credibility which provides great support for my charges. I was a Navy pilot in World War II, an international airline captain for many years, federal air safety agent given the assignment to correct the conditions resulting in an unprecedented number of air disasters, author of numerous books, and a top expert on aviation matters, with massive amount of documentation to support my charges.
- On page eight of the attempted filing begins a description of how Justice Department personnel (your prior employer before being appointed to the bench) criminally covered up for these

criminal and subversive activities.

- On page 13 I detailed the pattern of Ninth Circuit federal judges blocking the reporting of these crimes and how their obstruction of justice continue to inflict great harm upon national security, the lawful function of government offices, and the deaths and other harm suffered by many people as a result of these Trojan horse-like crimes.
- The entire document, as specifically stated on page 20, described how the conduct of federal judges met the legal criteria for calling the federal courts a racketeering enterprise.

In the event you think you are above the law, let me make a few comments:

- As a Navy pilot in World War II, I didn't risk my neck to come back and have a group of corrupt federal judges inflict upon the country that I was helping to protect, and upon me, great harm through Trojan horse corrupt, criminal, and subversive activities.
- I, and every other person in the United States, has a right to honest judges, and to take whatever action is necessary to expose and remove corrupt judges.
- Any judge who blocked the reporting of these federal crimes has been guilty of numerous criminal offenses arising from obstruction of justice, and complicit in the harm arising from their misconduct. I have written books for the sole purpose of showing how this corruption, and the cover-ups by people including federal judges, have become complicit in the great harm suffered by the United States and its people. You had the benefit of knowing the resulting harm occurring on September 11, 2001, from the failures of people responsible for the nation's air safety. That breakdown is riddled with documented hardcore corrupt and criminal acts. Despite this knowledge, you joined the long list of federal judges blocking the exposure of these matters, and protecting the criminal elements that continue to remain in a protected status. More harm will obviously be made possible by your obstruction of justice.
- A copy of your undated order refusing to file the papers that I submitted is enclosed. You make reference to an order of September 21, 1991, in case 91cv 1432, which appears to be the order by U.S. district judge Stanley Sporkin (former CIA legal counsel) permanently barring me from federal court. You enlarge on your obstruction of justice by supporting orders permanently stripping a former federal agent, and witness, of their right, and their responsibility, to report criminal activities to a federal court, and also deprive that person of the legal and constitutional due process defenses to seek relief from the concurrent personal and financial harm that accompanied the obstruction of justice.

While I had federal air safety responsibilities I witnessed the arrogance and corruption that caused or made possible the deaths by cremation or dismemberment of countless numbers of men, women, and children, and I feel you conduct joins the many other federal judges who have made this possible. The pictures of men and women jumping out of the World Trade Center to their deaths—while a group of corrupt federal judges blocked every attempt to report the criminal conditions making their plight possible.
