Ref: David Correa and the need to correct government drug laws

To Mr. Burns:

Very briefly, I have been in communication with David Correa for about a year and he told me about the letter you were writing on his behalf. I don't know the type and the intensity of the activities for the Aleph Institute, and don't know if the following information is of interest. A brief description of how I can help those few people or groups really concerned about the drug laws and the drug problems.

I have spent over 30 years as a crusader exposing evidence of high-level corruption in government. Along the way I have become friends with and the recipient of a great amount of data and hard evidence from dozens of present and former government agents, and others. This evidence far exceeds what is needed to show that:

- Government personnel have been smuggling drugs into the United States for decades.
- Government personnel in all three branches of government have been covering up for these activities.
- Simultaneously, government personnel have legislated draconian incarceration, conspiracy and forfeiture laws directed to those charged with drug offenses. Many of those who were charged and sentenced to long prison sentences were falsely charged, convicted on perjured testimony, sentenced to prison terms totally out of proportion to the severity of the offense.
- This evidence, if properly used by people and organizations, can attack the criminal and subversive drug smuggling and protection by government personnel; force the repeal of many of these drug-related laws and practices, and bring about the release of many people in prison who are victims of these problems.

I'm enclosing some flyers relating to my latest book, *Drugging America, A Trojan Horse*. I make no money in these activities but feel a responsibility to fight what I feel is a Trojan Horse type of outrage against the American people. I have not been impressed with the lack of help from people and groups that have a responsibility.
