Dear Mr. Lajud:

As a result of court-admissible evidence brought to my attention, I am making higher government officials in Mexico aware of several serious crimes against Mexico by agents of the United States government. This information is being conveyed through you and your office.

The evidence brought to me through declarations, affidavits, writings, and verbal statements from a former agent of the United States government indicates the following matters of great importance to Mexico, its people, and to the people of the United States. The evidence indicates:

- Criminal misuse of a Mexican airstrip for drug trafficking from Colombia to the United States, under the control of an agent of the United States Drug Enforcement Administration (DEA), a division of the United States Department of Justice. The name of this DEA agent will be provided to the proper authorities at an appropriate time.
- The murder of a Mexican national at this airstrip by that agent of the U.S. Drug Enforcement Administration. The murder was perpetrated because the Mexican national discovered the identity of the United States DEA agent. The murdered Mexican national was one of several cargo handlers loading and unloading drugs and chemicals between aircraft bringing drugs from Colombia, and aircraft bringing 55 gallon drums of chemicals from the United States to be used for processing cocaine. That murdered Mexican national was recruited at Los Mochis in Mexico for work at the airstrip.
- The murder of a Mexican journalist in Mexico, shortly after he started investigating these matters, was probably due to an attempt to cover up for the involvement of U.S. agents in these crimes against Mexico.
- Aiding and abetting of these crimes against Mexico and Mexican citizens, and against the American people, by persons in control of the U.S. Department of Justice and its various divisions, including the Drug Enforcement Administration (DEA), U.S. Attorney, Federal Bureau of Investigation (FBI), and the Immigration and Naturalization Service. They blocked criminal prosecution of the DEA agent; they blocked exposure of the drug trafficking operation at the Mexican airstrip controlled by the DEA agent, and thereby aided and abetted these criminal acts.
- These crimes are in character with other known and documented activities by agents of the U.S. government. The murder and drug trafficking, implicating agents of the U.S. government, are in character with what I, a former federal agent, and a coalition of several dozen U.S. agents and deep-cover operatives have discovered during the past 10 years. The cover-ups, the obstruction of justice, the continuation of the criminal activities, are documented standard operating procedures by people holding key positions in the government of the United States.

- Major cover-ups and obstruction of justice in the United States. One of the reasons why I am providing the Mexican government with this information is that it is not only Mexico and its people who are being harmed by the drug trafficking by agents of the U.S. government, and the murder of innocent people, but also U.S. citizens. Because of the massive cover-ups in the United States of these crimes by those in control of the U.S. Department of Justice and other government agencies, the cover-up by all of the U.S. Congress, and the cover-up by most of the U.S. broadcast and print media, I am relaying this information directly to the Mexican government.

My Credibility

I am a former inspector and investigator in the government of the United States, who discovered during the past 30 years patterns of documented corrupt practices involving federal officials in all three branches of government. Over two dozen government agents have provided me with additional court-admissible evidence during the past ten years.

The fact that other agencies of the U.S. government covered up for these crimes compounds the nature of the crimes against Mexico and its people.

A Major Scandal Against Mexico and Its People

The murder of a Mexican national, on Mexican territory, by an agent of the U.S. government, to cover up for a criminal drug trafficking operation conducted by a U.S. agent on Mexican soil, has serious implications for Mexico, its people, and produces additional evidence of interference in the operation of other government by certain people in control of the United States.

Any Mexican official who covers up for the murder of a Mexican national by an agent of the United States government, on Mexican soil, while that U.S. agent is using Mexico for an ongoing drug smuggling operation, would be aiding and abetting these crimes against Mexico and its people.

My primary interest in providing this information to Mexican officials is to expose the corruption by U.S. government officials that are inflicting great harm upon many innocent people, and being about the subversion of the government of the United States, as these same people have done to the governments in other countries. I am also interested in focusing attention on the "political" prisoners in the United States, those government agents and citizens imprisoned to silence their exposure of government corruption.

Evidence is Available To Mexican Authorities

I, and this former government agent who filed an official report of the murder of the Mexican national and the DES role in drug trafficking operation in Mexico, are ready to present evidence that we, and many other government agents, have discovered.
