Ref: Information that is equal to, if not more serious, to the torture issues that enabled terrorists to successfully commit several dramatic terrorist attacks on major U.S. targets. This information is provided by a former federal agent and one of his sources: a mole in the al Qaeda cell headed by Ramzi Yousef

To Program Director:

The attached letter is one that I faxed to U.S. Attorney General Eric Holder on April 22, 2009. That letter was based upon inside information that I received from several sources, including one who was a mole in the al Qaeda cell headed by the infamous Ramzi Yousef. The highlights in that letter includes:

- FBI agents in the New York City offices were receiving periodic reports from a former Mafia soldier who had obtained the confidence of Ramzi Yousef and became a mole inside that key al Qaeda cell.
- That mole was providing FBI agents in the New York City area with advance information on several terrorist attacks on major U.S. targets. Each of those terrorist attacks did subsequently occur.
- Higher FBI-DOJ personnel withheld that information from other government entities that could have taken steps to prevent the terrorist attacks that did subsequently occur.
- The reason for withholding the information from other government entities was to prevent the "mole" from being recognized as credible.
- That mole was to testify in several murder trials about the murders his father, a famous and feared murdered, committed with a key FBI supervisor in the New York FBI offices.
- The collateral effect of withholding that information was the deaths of nearly 4,000 people and thousands of injuries..
- The bizarre contradiction to this scenario is that White House politicians were ordering the torture of often low-level detainees while FBI-DOJ personnel had earlier withheld far more critical information from an al Qaeda member who masterminded the 1993 bombing of the World Trade Center and the planned simultaneously bombings of 11 U.S. airlines departing Far East locations.
- These issues have even worst tentacles, but that can wait for another time.

This information is provided to you for two reasons. (1) An attempt to have you provide this information to your readers so as to force an investigation into these serious charges from reliable sources; and (2) to put you on record as being made aware of these serious charges. The prior record of withholding similar information has had tragic consequences.
