Ref: Comparing your response to the FBI Agent Hanssen affair

To Representative Coble,

On January 29, 2001, I sent to you a detailed letter describing a pattern of criminal, subversive, and treasonous acts, their pattern of documented cover-ups by federal judges, and the corrupt misuse of federal courts to accomplish the cover-up of these matters. Under your congressional duties, and under federal criminal statutes, you had a duty and position of trust to take meaningful actions. Instead, you continued the cover-ups, which are felonies under Title 18 U.S.C. §§ 2, 3, and 4.

Your letter of February 8, 2001, in response to that earlier letter, provided me a tinge of nostalgia. It reminded me of the years of cover-ups and obstruction of justice by members of Congress that I started recording while I was a federal agent reporting documented criminal activities associated with a series of fatal airline crashes occurring in my area of federal air safety responsibilities.

At that time, and initially, I was a federal inspector responsible for air safety at the world's largest airline during a time when documented criminal activities played a key role in many crashes and many deaths. Congressional cover-ups made it possible for these federal offenses, crashes, and deaths to continue, as first detailed in my book, the third edition of *Unfriendly Skies*.

My outrage at these criminal activities and the cover-ups by members of Congress, that aided and abetted the crimes and resulting tragedies, caused me to use my considerable assets to publicize these matters via books, several thousand radio and television appearances, and speeches. These exposure activities motivated dozens of other government agents to provide me with information and documentation of still other criminal activities in key judicial and other government positions. When I sought to provide evidence of these crimes to members of Congress, the standard pattern of cover-ups continued to occur. And now you continue the pattern.

Some of the government insiders that have provided me with data and documentation over the years, including former CIA agents, discovered the same congressional cover-ups. They testified to members of Congress behind closed doors about criminal and subversive activities, including years of CIA drug smuggling into the United States, and encountered the same congressional cover-ups. Again, due to the pattern of absolute congressional obstruction of justice that I have recorded for the past 40 years, the public is paying the consequences.

The harm suffered by America, and its people, from these criminal activities, and from the congressional cover-ups, is far worse and measurable, than the harm arising from the acts by FBI agent.

Sample Of Criminal and Subversive Activities Being Reported to Members of Congress

And Their Continual Obstruction Of Justice

In the area of aviation safety:

- Starting while I was a federal air safety inspector-investigator for the Federal Aviation Administration, responsible for federal air safety responsibilities at United Airlines while that airline was experiencing large numbers of fatal airline crashes for a 20 year period, I repeatedly offered to provide hard evidence of deep-seated air safety and criminal violations responsible for a series of specific airline crashes. By engaging in their culture of cover-ups and obstruction of justice, the federal crimes continued, with the expected crashes and deaths that such congressional misconduct made possible. These activities are described in the third edition of Unfriendly Skies and to a smaller extent in the third edition of Defrauding America.

Related to the national crisis arising from drug smuggling:

Great human tragedies inflicted upon men and women and their families arising from decades of drug smuggling by people acting under cover of government offices and covert government operations. My sources who have the evidence of this relationship include dozens of former government agents from the FBI, DEA, Customs, Secret Service, the military, the CIA-including the former heads of secret CIA airlines and secret CIA financial operations.

- Drug money going to politicians and both political parties, as described to me by people who delivered the money.

Fraud and harm inflicted upon America and its people by covert CIA operations:

- Harm inflicted upon national interests by covert CIA operations conducted within the United States, which includes:
 - CIA's role in drug smuggling.
 - CIA's role in the savings and loan scandal.
 - CIA's role in other financial crimes, including bogus bearer bonds.
 - Tampering with elections, such as arising in October Surprise scheme, as described to me by people who were part of the operation.
 - Other Criminal and Subversive Activities
- Funding of secret bank accounts for key politicians through covert CIA proprietaries, as described by former heads of such secret operations. Evidence was provided to me by CIA insiders, including one who was head of a large CIA financial operation based in Honolulu.
- Pattern of other corrupt covert activities as described in the third editions of Defrauding America and Unfriendly Skies and the first editions of Drugging America and Disavow.
- Sampling Of Documented Judicial Corruption
- In the area of documented judicial corruption, the criminal misuse of the federal courts, that fall within your area of oversight responsibilities, include:
 - Federal judges and Supreme Court justices repeatedly blocking the reporting of criminal and subversive activities to a federal court, as required by the federal crime reporting statute, Title 18 U.S.C. § 4. These documented obstruction of justice acts by federal judges are felonies under Title 18 U.S.C. §§ 2, 3, and 4.
- Harm inflicted upon me by federal judges (and other former government agents) for seeking to report the criminal activities. These acts were felonies under Title 18 U.S.C. §§ 35, 111, 153, 241, 242, 245(b)(1)(B), 246, 371, 1341, 1343, 1503, 1505, 1512, 1513(b), and 1515(a).
- Pattern of hardcore subversion of the laws and Constitution of the United States, the rule of law, and the courts. When I exercised legal and constitutional defenses against the violations, orders were issued barring me access to the courts. When I did exercise due process remedies, I was charged with criminal contempt of court. These repeated judicial acts are felonies under Title 18 U.S.C. § 241.

- Patterns of judicial corruption, as documented in numerous federal filings, including a federal lawsuit filed by me in the U.S. district court at Reno, Nevada, in which the judicial corruption and obstruction of justice continues.
- Scheme using federal judges to corruptly take the \$10 million in assets that funded my exposure of criminal activities in key judicial and government offices. (Details in the websites at the top of the first page, and in the books, in a federal lawsuit that is on the Internet, (www.defraudingamerica.com/complaint_reno.html), and in the books, *Defrauding America* and *Unfriendly Skies*.)
- Twenty years of uninterrupted hard-core civil rights violations, combined with total denial of due process defenses, as part of the scheme to destroy my ability to report the criminal activities and the judicial involvement in cover-up. Details of these judicial crimes can be found at www.defraudingamerica.com/lawsuit_progress.html.
- Each of these corrupt and criminal acts were repeatedly brought to the attention of the justices of the U.S. Supreme Court, on the basis of their supervisory responsibilities over the corrupt judges, and on the basis of my legal right to seek relief in the Supreme Court.
- Issuing unlawful and unconstitutional orders permanently voiding my right to federal court access and the rights and protections guaranteed by legislation and the Constitution of the United States. The intent of these orders was to block the reporting of criminal and subversive activities to a federal court and block the exercise of federal defenses against the judicially inflicted civil and constitutional violations.
- Prison for reporting criminal activities in key judicial and government offices. When I did seek to report additional criminal activities and provide supporting evidence, Justice Department prosecutors and federal judges joined forces to charge me with criminal contempt of court and initially sought a three-year prison sentence. I was nearly 70 years of age at that time and had recently undergone a six-coronary-bypass open-heart surgery.

Aiding and Abetting of These Offenses By Members Of Congress

Pattern of repeated cover-ups by members of Congress. Starting from when I sought to report major criminal activities as a key FAA inspector responsible for air safety at the world's largest airline, during a period of repeated fraud-related airline crashes, through the years when other federal agents and deep cover operatives provided me with evidence of criminal and even subversive activities against the United States. These criminal activities are described in the books listed at the top of this page, and includes decades of drug smuggling into the United States by people acting under cover of various government offices and covert government operations. The criminal activities were also treasonous. The cover-up of these activities made the parties guilty as the perpetrators.

Compare the punishment. Thousands of men and women have been sent to federal prison for offenses that are peanuts compared to the offenses that I and my group of other insiders sought to report. Thousands of men and women have been sent to prison for knowing of a federal crime and not promptly reporting it, such as overhearing a conversation relating to drugs. You and other members of Congress have repeatedly known of federal crimes of far greater severity and have repeatedly covered up. Simultaneously, you legislate laws that have sent thousands of men, women, mothers, to federal prison for such relatively minor matters as failing to report a conversation relating to drugs while you commit felonies arising from cover-ups of far graver crimes, some of which are subversive.

Who Were Guilty Of the Worst Abuse Of Trust: Members of Congress--Or Hanssen?

This letter does not dismiss the harm made possible by former FBI agent Hanssen. However, it does show that far greater measurable harm has been inflicted upon the United States and its people by the criminal and subversive acts that I and my several dozen former government insiders sought to expose, which was aided and abetted by the members of Congress who engaged in the obstruction of justice.

In the Hanssen affair, the criminal misconduct of that FBI agent was not compounded by congressional cover-ups, which in this instance, consists of years of congressional cover-ups and great tragedies inflicted upon individual Americans.

Validity Of the Allegations Of Criminal and Subversive Conduct

The proof of the criminal activities that we brought to your attention arises from our backgrounds in government and upon the evidence we acquired. These people include myself, a former federal agent, and a group of other federal agents from such agencies as the FBI, DEA, Customs, Secret Service, and CIA, including the former heads of secret CIA airlines and secret CIA financial operations.

Continuing Great Harm Upon the People From Document Congressional Cover-Ups

Despite this proof, far beyond what exists in the Hanssen matter, and despite the gravity upon the nation and its people, you and other members of Congress have continually engaged in cover-ups, with tragic consequences for many innocent people.

Feigning Outrage While Engaged In Worse Offenses

You and other members of Congress have feigned outrage at the subversive acts of FBI agent Hanssen, as if you were not yourself involved in worse offenses through cover-ups of far-worse criminal and subversive acts. This cover-up has made possible the infliction of even greater measurable harm upon the internal security of the United States and the American people than anything Hanssen may have done. This is not said to protect Hanssen, but to put your offense into perspective.

Reliability Of the Charges

My qualifications, and those of my dozens of government insiders, to determine the existence of the criminal activities that I describe in part in my various books (listed above), and the gravity of these crimes upon the people of the United States, do not permit you to shirk your responsibilities through off-the-shelf generic excuses.

This letter will appear on an Internet site that receives heavy traffic. Possibly a few of those people will have enough backbone and civic responsibility to help fight this cancerous corruption by people in key positions within the three branches of government
