Dear Representative Gonzalez:

This letter is to further document certain facts placed in the upcoming book, *Defrauding A Nation*, in which you play a key role. You and I have been partners in the developing endemic corruption within the federal government. Since 1965, when I was a federal investigator holding authority to make such determinations, I reported to you a pattern of criminal activities in which tentacles of the various crimes went to a two-headed form of Octopus: renegade Justice Department attorneys/officials and federal judges. I reported the crimes to you as part of my responsibilities under federal crime-reporting statutes, including Title 18 U.S.C. § 4. Your responsibility was to receive my testimony and evidence. Instead, you aided and abetted the ongoing escalating crimes by federal officials. This coverup made possible many deaths in fraud related airline crashes. It made possible the financial defrauding of thousands of Americans who were persuaded by your legal buddies to exercise the protections of Title 11, and who were then stripped of their assets by the racketeering activities in federal courts. Your coverup made possible the perpetration of other crimes, with no fear of prosecution. These criminal enterprises included (a) "October Surprise treasonous and subversive activities; (b) rampant drug smuggling into the United States by covert CIA operatives; (c) looting of covert CIA savings and loans by CIA operatives, including Silverado, MDC, Red Hill, and others; (d) persecution of informants and victims by Justice Department attorneys/officials, who aided and abetted the coverups; (e) killings and mysterious deaths of informants, continue to escalate.

Except for your obstruction of justice, these crimes, these deaths, this defrauding of the United States, could not have escalated to the level that it now threatens our form of government. Those federal officials over whom you have supervisory and impeachment responsibilities, and whose federal offenses I brought to your attention,¹ includes:

- **Air disaster related pattern of hard-core corruption.** Deeply ingrained pattern of air safety and criminal acts related to specific fatal airline crashes. As I described in the third edition of *The Real Unfriendly Skies—Saga Of Corruption*, over 2,000 people were killed, solely in programs for which I had federal air safety responsibilities and related knowledge, in airline crashes in which the direct causes of the crashes were caused and permitted to occur by the hard-core air safety and criminal violations. My evidence arises from my official duties as a federal air safety investigator and acquired during forty years of aviation experience.
- **Chapter 11 judicial corruption.** Rampant pattern of corruption in Chapter 11 courts, perpetrated by federal judges, federal trustees, cooperating law firms, Justice Department officials (of which the Inslaw scandal is one example). Thousands of American citizens who exercised the purported protections of Chapter 11 to protect their valuable assets were criminally stripped of these assets in a vast racketeering enterprise misusing the power of federal courts. Evidence suggests that covert CIA activities are also implicated in Chapter 11 corruption, partly to sequester evidence of looting of covert CIA savings and loans by CIA operatives. My evidence arises from being a victim of the corruption, and investigation into the pattern of corruption for my forthcoming book, *Defrauding A Nation*.
- **"October Surprise."** Treasonous and criminal activities undermining the government of the United States in the conspiracy known as "October Surprise," implicating private citizens and federal officials. My evidence arises in part from being a confidant to a navy captain and high

CIA operative, who gave to me declarations and statement of details of grave misconduct by covert CIA operatives/officials. This misconduct covers the part played by CIA operatives in the HUD and savings and loan scandals, and others yet to be publicized.

- **CIA drug smuggling.** Drug smuggling into the United States by covert CIA operatives, constituting a major part of the nation's drug problems.
- **Looting of covert CIA lending institutions.** Large scale involvement of CIA operatives in the savings and loan and other lending scandals, with diversion of funds into secret CIA bank accounts and to the operatives.
- **Killing and persecution of informants/victims.** Persecution, killings, mysterious deaths, of informants/whistleblowers/victims, by Justice Department attorneys/officials and federal judges, including blatant nine-years of persecution of me. Evidence is accumulating through a group of public-spirited citizens seeking to circumvent the felony obstruction of justice by every known government and non-government check and balances, and investigative work for the forthcoming book.²
- **Obstruction of justice by checks and balances.** Felony coverup by every known government and non-government check and balance. Members of Congress, the mass media, Justice Department attorneys/officials, federal judges, inspector generals in the various government agencies and branches of government, have all feloniously blocked the reporting of these crimes. The attached list, previously brought to your attention, shows the tactics used by the Justice Department attorneys/officials and federal judges, to block my reporting of the crimes, and to block my defenses against the retaliatory acts.
- **Killings, mysterious deaths, and persecution of informants/victims.** Also included in the attachment is a partial list of informants who were killed, who mysteriously died, or were/are being persecuted, while trying to do the same thing that I am doing, as we have met our responsibilities to our country by reporting and trying to halt the federal crimes. Justice Department attorneys/officials and federal judges,³ have engaged in a nine year pattern of persecution against me, criminally misusing the powers of their offices, blocking my reporting of the federal crimes in which their group are heavily implicated.⁴
- **Justice Department and federal courts as the dual heads of the Octopus.** The information that I provided you showed a literal Octopus type of criminal activities, with Justice Department attorneys/officials and federal judges/justices at the center. From the Justice Department and judicial obstruction of justice and persecution of informants/victims, the tentacles reach out into (a) the Inslaw scandal and criminal mindset; (b) Chapter 11 judicial corruption; (c) October Surprise; (d) CIA participation in massive drug smuggling; (e) large scale looting of lending institutions by CIA operatives; (f) air disaster related corruption; (g) criminal misuse of the Justice Department and federal courts; (h) BCCI; (i) felony persecution of informants and victims by renegade Justice Department officials and federal judges/justices; (j) killings and mysterious deaths of informants and victims by persons unknown, but suspiciously linked to the Justice Department and federal judicial misconduct.

One example of the relationship between Justice Department corruption and killing of those exposing the relationship was the killing of free-lance writer Danny Casolaro,⁵ who sought to report what I had long-ago discovered. Casolaro discovered the link between the Justice Department and October Surprise, Inslaw, and BCCI.

My discoveries commenced with the pattern of air disasters⁶ that were linked to the deeply ingrained federal air safety and criminal acts, and the obstruction of justice related to these acts. I

⁴ I am in the fifth year of repeated criminal prosecution, in which these son-of-a-bitches hold that it is a crime to (a) report federal crimes to a federal court, as required to be reported under federal criminal statutes, including Title 18 U.S.C. § 4 (misprision of felonies); (b) to exercise federal remedies, invoking federal court access and relief, under the laws and constitution of the United States (as I exercised declaratory and injunctive relief remedies to halt the great harms inflicted by them upon me.

then discovered the Chapter 11 link, the October Surprise link, the Inslaw link, the CIA looting of savings and loans, and the drug smuggling link, among others. Even through I held federal authority to make such determinations as I made, every known government and non-government check and balance, including members of Congress, feloniously aided and abetted the crimes by their felony coverups/obstruction of justice.

I reported the crimes to you (and every other senator in the United States and most of the Congressmen). I sought to provide testimony and hard evidence to support the charges, but you blocked the presentation of this evidence. I asked you for help to halt the vicious persecution and harms inflicted upon me, by those over whom you have control. You had a responsibility under federal statutes,⁷ to use your federal authorities and responsibility to halt the crimes.⁸ All That I got from you was another coverup, as reflected by your October 10th letter.⁹

The Senate Intelligence Committee has already feloniously covered up in the Gates hearing. They knew that Gates was a key party to the October Surprise, to the drug smuggling and looting of savings and loans by CIA operatives. By avoiding any mention of Gates involvement in these offenses, the intertwined web of corruption was kept from the public.

You are on several committees that have direct supervision of the hard-core subversive activities I described, including the Judiciary Committee which has oversight responsibilities over the federal judges and Justice Department attorneys. You are on the foreign relations committee, which has supervisory responsibilities over the treasonous acts by CIA operatives and officials. Many Americans have been sent to prison for alleged failure to report federal crimes. But you and most members of the Senate and House, who have a greater responsibility to report and halt these crimes than the average citizen, have placed an impenetrable block to the reporting of these crimes. You have repeatedly committed felony obstruction of justice, felony coverup, misprision of felonies, knowing that the United States and its citizens were being defrauded, sometimes out of their lives and sometimes financially destroyed. You continue to retain the position of trust that requires you to assist the victims and the informants, and bring to justice those committing the crimes. But then, this would educate the public to where they would recognize the pattern of corruption by the members of the Senate and House.

Thousands of Americans are being financially destroyed by the corrupt actions of federal judges, federal trustees, cooperating law firms, Justice Department attorneys, while you sit on the Judiciary Committee, maintaining a coverup that aids and abets the crimes. You, and other members of Congress, act like crooked police chiefs, allowing criminal elements, in control of key federal entities, to rape and plunder. You know that federal judges/justices, including the Justices of the U.S. Supreme Court, are aiding and abetting these crimes, and criminally misusing their offices. You all know that these judges/justices are engaging in a widespread scheme to obstruct justice. You know they are misusing their office, charging me with federal crimes for reporting criminal enterprises in which they are implicated. They are repeating charging me with federal crimes for defending myself against their retaliatory acts, and punishing me for using¹⁶ constitutionally and statutorily guaranteed remedies against the harms they are inflicting upon me.

While you and your colleagues on the Judiciary committee argue the fine points of "natural law," federal judges and justices (over whom you have supervisory and impeachment responsibilities) are openly destroying the basic rights and protections under our form of government, and engaging in

⁹ The letter referred to one issue, the October Surprise, and ignored the many other criminal enterprises, and ignored the civil right and criminal violations inflicted upon me.

¹⁰ They have stripped me of my ten-million dollar estate, without any hearing, violating blocks of basic constitutional and statutory protections, and then barred me from defending myself. Their is even a prison sentence waiting to be carried out, because I exercised federal remedies to defend against the criminal seizure of my life's assets. And these son-of-a-bitches are escalating these subversive acts, knowing that you and the fellow thugs, members of Congress, will protect them to the end. After all, aren't you both engaged in the same defrauding of the United States and its people!

subversive destruction of our form of government. It is now a crime, under the holdings of federal judges and justices, upheld by the Justices of the U.S. Supreme Court, for (a) a citizen/victim to report a federal crime as required to be reported by federal criminal statutes; and (b) for a victim of massive violations of federally protected rights to exercise the right to federal court access and relief. The implication of this pattern of judicial misconduct, reaching to the Supreme Court justices, are awesome, and reflects the advanced stage of selective anarchy brought about by the renegade federal officials over whom you have supervisory responsibilities. Federal judges, including Lawrence Silberman, the Justices of the Supreme Court, are blocking the reporting of the treasonous and subversive activities, in which they themselves are deeply implicated.¹¹

If any one of these major scandals ever gets the public's attention,¹² my upcoming *Defrauding A Nation* book will be sure to identify you and members of the Senate and House who made much of this endemic corruption possible.

While you play your games, the harms suffered by many, continues. The massive defrauding of America continues. Simultaneously, the powers of federal government are again sending me to prison for reporting the crimes and exercising constitutional protections. I have been stripped of my life's assets and made literally destitute, while you and the other SOB's defraud the nation and the public, with your obstruction of justice and the many other offenses that are routinely committed by one of the most corrupt bodies in the United States. Fortunately for you and the other members of the conspiracies that you have joined by your coverup, the mass media is keeping the lid on the scandals while they also aid in defrauding the nation and the public by their complicity of silence.
