Ref: Former federal agent provides another side to the torture issue.

To Representative Harmon:

I admire you for your willingness to have spoken out on the torture issue years ago, before anyone else found it politically beneficial to do so. As a former federal agent representing a coalition of other former government agents and insiders in trying to expose serious wrongdoing in government, I continue to discover areas of misconduct that have in the past, and continues today, to threaten and inflict great harm upon important national interests. Two issues are raised in this fax that are in your area of interest and responsibilities.

The first issue relates to the contradiction between the use of brutal and illegal torture on sometimes low-level detainees or those no longer in the loop, while high-level FBI-DOJ personnel were "deep-sixing" information they had received from the highest al Qaeda source possible. Some details follow:

- One of my many sources is a former Mafia soldier in New York City who acted as a mole inside a key al Qaeda cell. He obtained the confidence of the infamous Ramzi Yousef, who over a period of several months provided him with current information on al Qaeda activities and plans. These included information on several terrorist attacks on major U.S. targets—that did occur. As he conveyed to me, and as shown by FBI documents that he provided to me, he passed that information on to local FBI agents, who considered the source and the information to be extremely valuable. Probably the most valuable source the FBI ever had on al Qaeda operations.
- That information was not acted upon by the FBI, nor passed on to other government departments that could have taken steps to prevent the success of those attacks. The reason why the information was not passed on was to prevent that former Mafia soldier from being recognized as credible. He was expected to be a key witness in several murder trials concerning the series of murders that his father, a feared Mafia capo, had committed with the help of a key FBI supervisor in the New York City offices. The FBI supervisor involved in the murders, and the years of high-level FBI-DOJ cover-ups of that relationship, would obviously have serious consequences for the guilty. That self-protection reaction enabled the al Qaeda group to carry out the terrorist attacks that killed nearly 4,000 people. .

The second issue involved, and now this puts you on the spot if you don't conduct a meaningful response to these important charges coming from reliable sources. And that is the subject of:

- A culture in the FBI-DOJ that engages in murders of U.S. citizens and the cover-up of that culture by high-level DOJ personnel. The existence of that culture is supported by the fact that FBI agents in the Boston FBI offices were shown to have engaged in murders with organized crime figures for years, with high-level FBI-DOJ cover-ups.

- The effect of that culture would obviously require monumental changes in the operation and oversight of the nation's top law enforcement department.
- Over the years, I have accumulated evidence to show that equally serious—or more so—misconduct exists in that agency that suggests that the culture is the greatest threat and source of harm to the American people.

There are over 1,000 pages of documents and information at one of my Internet sites that seek to circumvent the endemic cover-ups. Among the various Internet sites that address the issues raised in this fax are the following:

I am available for more information, and can make available two witnesses that were closely involved in these matters. I have no ax to grind other than to publicize the misconduct that continues as a threat and source of harm to the United States, and will continue until some courageous person or group has the backbone to help bring these matters to the public's attention.

The misconduct raised in this fax are only a small part of what I have discovered during the past 40 years. These discoveries started after I was given the assignment many years ago to correct the conditions responsible for the worst series of airline disasters in the nation's history. What I discovered in the government assignment caused me to become an activist against corruption in government. As I warned people then, any cover-up would enable the corruption and the consequences to continue. The cover-ups continued, the corruption continued, and the catastrophic consequences continued. The same applies today, as cover-ups will continue to have devastating consequences for the people of the United States and the nation's survival.
