Dear Representative Lee:

Because of your rhetoric showing an interest in addressing the CIA drug smuggling problem, I am making you aware of a coalition of present and former government agents and deep-cover operatives who have contributed to a book that provides proof of the CIA drug smuggling into the United States, and its allies in organized crime and allies in coverup.

Never before have so many government agents come forward to provide proof of the truth behind the drug crisis that constitutes not only criminal conduct, but subversive, with a sordid coverup by virtually every government and many non-government check and balance. Worse, while protecting the tons of drugs smuggled into the United States by people with drug ties, prosecutors are targeting thousands of men and women, sentencing them to long prison terms, for either imaginary conspiracy charges or for peanut-quantity of drugs.

This letter is providing you with information-as well as putting you on notice-of these facts. You, of course, have a duty to insure that the evidence provided by this coalition of government agents be brought to the people's attention and that meaningful corrective actions be taken, keeping in mind the many government and non-government interests that will block and discredit any such efforts.

This new book can provide great assistance to any group interested in causing the repeal of the draconian mandatory minimum sentencing statute and the broad application of the conspiracy and forfeiture statutes. The basis for bringing about these changes is the evidence provided by a large number of present and former government agents for inclusion in the book, *Drugging America-A Trojan Horse*. The key points to force these changes are stated in the attachment to this letter.

The book *Drugging America* and the many insiders who have contributed evidence for it, can provide the basis to *force* long-overdue major changes. It can be used as a catalyst.
