Reference: Putting you on notice of the consequences of earlier cover-ups

To Representative Miller,

Some years ago I brought to your attention a pattern of criminal activities in government that continued to inflict grave harm upon the United States, and requested that you exercise your legal and moral responsibilities to assist me in exposing these matters. You refused. The corrupt and criminal acts continued, and played key roles in continuing to inflict great harm upon the United States and its many interests. Many people have been sent to federal prison on the Title 18 U.S.C. § 4 misprision of felonies charges that are far less offenses than those that you covered up.

The combination of my books, my Internet sites, and legal filings, could be causing these matters to come to a head, and I want to make a record of as many people as possible, who had a duty to act and who were too cowardly or too protective of the criminal activities, who assisted in the cover-ups. The attached January 2, 2001 letter to Supreme Court justice Rehnquist puts you on notice of certain aspects of the criminal activities brought to your attention. The letter focuses primarily upon the corrupt and criminal acts in the federal courts that covered up for the criminal acts that I and my group of other former federal agents sought to report. This letter describes:

- Pattern of federal judges blocking me, a former federal investigator, and my group of other former federal agents, from reporting patterns of criminal activities to a federal court under the federal crime reporting statute (18 U.S.C. § 4). These documented obstruction of justice acts are felonies under Title 18 U.S.C. §§ 2, 3, and 4.1
- Federal judges repeatedly retaliated against me, a former federal agent and witness, for attempting to report these criminal activities. These are federal crimes under Title 18 U.S.C. §§ 35, 111, 153, 241, 242, 245(b)(1)(B), 246, 371, 1341, 1343, 1503, 1505, 1512, 1513(b), and 1515(a). The retaliation included charging me with criminal contempt of court, sentencing me to federal prison at the age of 70 for having defied earlier injunctive orders barring me from access to the federal courts for the remainder of my life, and more.
- Federal judges joined in a scheme involving a sham lawsuit that targeted the \$10 million in assets that funded my attempts to expose the documented corruption in key judicial and government

Whoever, having knowledge of the actual commission of a felony cognizable by a court of the United States, conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States, shall be fined under this title or imprisoned not more than three years, or both.

offices. These criminal and even subversive activities are described in my books, including the third editions of *Defrauding America* and *Unfriendly Skies* and the first edition of *Drugging America* and *Disavow*. They are also described in my various heavily Internet sites, including [www.defraudingamerica.com](http://www.defraudingamerica.com). The lawsuit violated dozens of state and federal laws and constitutional protections, and federal judges aided and abetted the bizarre lawsuit by denying to me the federal defenses that would have halted the lawsuit in its tracks. The primary federal remedies were under the Civil Rights Act and the Declaratory Judgment Act.

- Federal judges systematically issued orders forever barring me from access to the federal courts, which conveniently barred me from reporting the criminal activities to a federal court, and barred me from exercising the federal defenses specific for the type of violations being perpetrated.
- Federal judges charged me with criminal contempt of court for filing federal actions under the Declaratory Judgment Act and Civil Rights Act, thereby making it a crime for a citizen to exercise legal and constitutional due process against record-setting violations of federally protected rights. Help defraud the United States and your constituencies; continue the felonious cover-up.
