To Mr. Traficant,

Joe Occhipinti suggested that I send to you my latest book, *Drugging America, A Trojan Horse*, which is enclosed. I would appreciate a response that it has been received. Because of your busy time schedule, let me highlight a few points relating to the book:

- Most of the data in the pages is based upon the information and documentation given to me over the years by present and former government agents and deep-cover operatives, and former drug traffickers.
- Most of the information in the book, as it relates to drug trafficking by the CIA, is further corroboration of what other government agents and deep-cover operatives had conveyed to me by data, documentation, and affidavits for the past ten years, and which I detail in the third edition of *Defrauding America*, another book that I wrote.
- These sources include agents from the FBI, DEA, INS, Customs, Secret Service, CIA, among others.
- I first discovered the CIA drug trafficking in the 1950s while I was an airline captain flying out of Tokyo for Japan Airlines and while flying Moslem pilgrims to Mecca from various points in the Middle East.
- I am a former federal inspector-investigator who became an activist-crusader after discovering, while an FAA inspector, a pattern of arrogance and corruption within the Federal Aviation Administration related to a series of fatal airline crashes. The evidence is in a 4000-page hearing transcript, in my possession, from a four-month-long hearing in which I acted as an independent counsel.
- The evidence of CIA drug trafficking, aided and abetted by Department of Justice personnel, is without question.
- Most members of Congress have known of this CIA drug smuggling and liaison with drug cartels and organized crime.
- Neither political party will comply with their duties or those under federal criminal statutes.
- I have become the focal point for dozens of present and former government agents and operatives and have for years received various forms of evidence from insiders.

You know what was done to Joe Occhipinti when he was too much of a threat to the drug traffickers, as Justice Department personnel went after him, as Justice Department personnel have gone after many other whistle-blowers--some of them government agents--described in my various books.

I'm curious as to your response to this letter, these facts, and the enclosed book--which will be periodically updated as new information and new coverups occur.
