Ref: Contradiction between your statements on anti-terrorism failures and your record of complicity.

To Senator Feinstein:

As head of the Senate Intelligence Committee, you recently stated in response to the intelligence failures relating to the Nigerian terrorists on Northwest Airlines Flight 253: "I'd rather, in the interest of protecting people, overreact rather than under react." Let's look at the record of your actual conduct, and how it made possible not only the failings with the Nigerian terrorist, but in events that some would call catastrophic.

For years, I, a former federal agent, and my coalition of other former government agents and insiders have been providing you, via letters and faxes, information on ongoing corruption gravely affecting the American people and the nation, including national security, and especially, a series of preventable aviation disasters.

You had a responsibility as a member of congress to obtain further information and conduct hearings on matters so gravely affecting the nation, and a responsibility under the federal crime reporting statute, Title 18 USC § 4, to turn this information over to law enforcement entities that were not themselves implicated. 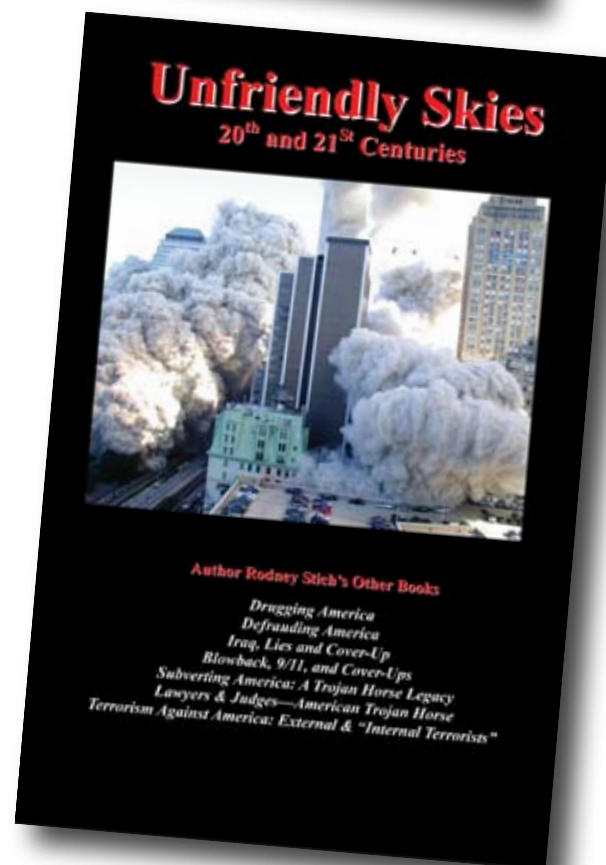
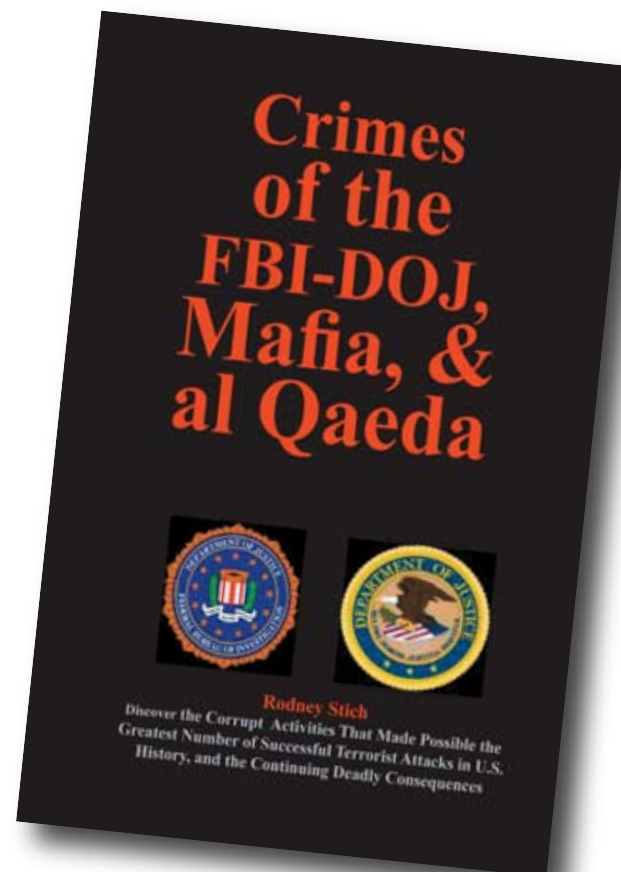
