Ref: Request help obtain evidence of FBI-Mafia links that is being blocked by federal prison officials, relating to FBI crimes similar to those with the Boston Winter Hill gang.

To Senator Feinstein:

This is a request for assistance to circumvent the block by federal prison officials of communications from inmates who seek to provide me evidence of criminal activities affecting national security. Starting while I was a federal agent, my attempts to report corruption in government offices has caused many other former and present government agents, and other insiders, to provide me with information relating to corruption adversely affecting national interests, including national security. One of these sources was a former member of a crime family in New York City who started to provide me with information about FBI agents providing the names of government informers to organized crime figures, with the subsequent murder of these informants. This is similar to the FBI culture in the Boston office with the Winter Hill gang. Justice Department officials have blocked these criminal activities being reported, just as they blocked exposure of similar activities in the Boston area with the Winter Hill gang.

As Justice Department personnel discovered the inmate providing me information relating to these criminal activities, the warden of the prison blocked all communications between me and that inmate (and several others). The ramifications of this blatant obstruction of justice is serious for national security. First, the murder of citizens seeking to report crimes against the United States is a major crime, especially when perpetrated with help of FBI agents. Second, with a culture like that in the FBI and Justice Department, other national security interests would obviously be affected. I discovered this obstruction of justice by Justice Department employees while I was a federal agent.

The enclosed copy of an October 20, 2003, letter from Warden Robert Hood shows the intent to block communications from inmates to me. Since my communications are strictly formal, with no reference to prison activities or other prisoners, there is no adverse impact upon prison activities. The only purpose in the blocks by Justice Department employees is to prevent information about crimes against the United States, implicating Justice Department employees, from being publicized. The warden refers to the protection of the public in blocking communications. Obviously, the criminal activities that constitute a culture in the FBI and other Justice Department offices constitute crimes against the public and the United States. Murdering government informants, with the help of FBI agents, is hardly in the national interest.

I've already made clear to you the catastrophic consequences of corruption in government offices, the coverup of such crimes, and the failure of people to assist in making this information known. As a former federal aviation safety agent, I have documented years of déjà vu aviation disasters made possible by this

combination of federal offenses. The refusal to act on my information of corruption of people in certain government aviation safety offices made 9-11 possible, and will make subsequent disasters possible. I hope your response will be somewhat more positive than your pre-9-11 response.
