Ref: Putting you on notice of conduct enabling series of preventable and forewarned continuing terrorist attacks on U.S. targets.

To Senator Schumer:

This letter to you from a former federal agent and his coalition of other former government agents and insiders provides insider information, with reference to supporting documentation, on high-level corruption that has made possible a series of catastrophic events upon the United States and its people. The continuation of the misconduct—and the resulting consequences—were made possible by the culture of cover-ups, especially from members of Congress. (Partial list of those letters are found on a related Internet site.)

Under your moral and legal responsibilities as a member of Congress, and as required by the federal crime reporting statute, Title 18 U.S.C. §§ 4,¹ this information is being provided to you. That criminal statute requires you, as a federal official, to receive the information offered by anyone with knowledge of a federal crime. Preventing this would be a felony. And in lieu of the prior consequences of cover-ups, such as 9/11, when this information was offered, and then covered up, you have an ever greater responsibility to react in a meaningful manner. (Turning this requirement over to Department of Justice personnel is not appropriate because of its history of complicity in the federal offenses.)

For credibility, I am a former federal agent that has for years been attempting to report corruption and other problems in key government positions associated with continuing tragedies. Over many years, I have also acquired a coalition of other former government agents and insiders that have provided information on major misconduct in key government positions. These are people concerned about the harm resulting from the corruption they discovered.

One of these sources is a former mole inside the al Qaeda cell headed by the infamous Ramzi Yousef, the mastermind behind the 1993 bombing of the World Trade Center and the planned bombing of a dozen U.S. airliners departing Far East locations. For nearly a year, that mole provided advance information on several major terrorist attacks that did occur, including 9/11. High level employees in the U.S. Department of Justice sequestered that information to prevent exposure of serial murders involving a key FBI supervisor—in your state. Most of them are still in key positions responsible for national security, after their felony cover-ups of murders resulted in 3,000 deaths on 9/11.

Just imagine what life would be like, were it not for them. The 9/11 hijackings, 3,000 deaths, people jumping to their deaths from the World Trade Center, followed by two unwinnable and deadly wars.

¹ Title 18 U.S.C. § 4 (misprision of felony). “Whoever, having knowledge of the actual commission of a felony cognizable by a court of the United States, conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States, shall be fined not more than \$500 or imprisoned not more than three years, or both.”

Some New York government personnel covered up for this matter, which expanded on the earlier crimes! They are also identified at www.defraudingamerica.com.

My quest to halt the corruption that continues to this day in an expanded way started with my assignment as a government airline safety inspector to correct the conditions responsible for the worst series of airline disasters in the nation's history. Included in that long line of fraud-related tragedies was what was once the world's worst airline disaster, directly affecting your New York constituents: the December 16, 1960, United Airlines crash into the Brooklyn area of New York City. IF the deep-seated culture of corruption, or the corruption related to several other aviation disasters at that time, had been addressed rather than covered up, some of the conditions that made possible the hijackings of four airliners on September 11, 2001, possible. And that was only one of many resulting tragedies.

The following are several references to the arrogance, corruption, criminal activities that have made the past decade of publicized and in some cases, covered-up terrorist attacks, possible.

- As noted earlier, cover-up of advance information on several of the worst terrorist attacks were high-level Department of Justice personnel. Their cover-up was perpetrated to prevent exposure of murders involving a key FBI supervisor in the New York City offices and to protect other DOJ personnel who knew of these murders and covered up for the crimes. That cover-up required withholding advance information on several planned terrorist attacks from government entities that could have taken measures to prevent the success of those attacks.
- The advance information on the planned terrorist attacks was provided to FBI agents in the New York City offices during an 11-month period by a former Mafia member that had infiltrated the al Qaeda cell headed by Ramzi Yousef. Yousef was the mastermind behind the 1993 World Trade Center bombing and the planned simultaneous bombing of a dozen U.S. airliners departing Far East locations, and probably the most important hands-on al Qaeda terrorist. That terrorist source was probably the most important source of information on planned terrorist attacks that the U.S. has ever received relating to al Qaeda plans.
- The reason why Washington DOJ personnel withheld the information—thereby blocking preventative measures to be taken—was their scheme to fraudulently discredit that mole in several future murder trials. That mole was to give sworn testimony about the serial murders that his father, a Mafia capo known as “The Killing Machine,” perpetrated with the help of a key FBI supervisor in the New York City offices.
- The consequences of that scheme made possible several successful terrorist attacks that killed nearly 4,000 people, which was then followed by the U.S. invading Afghanistan and Iraq, two countries that had either no role whatsoever in the attacks or less blame than those DOJ personnel.
- To cover up for this granddaddy of scandals related to the 9/11 terrorist attacks, 9/11 Commission members, controlled by key DOJ personnel, some of whom were directly involved in the prior cover-up scheme, omitted key information from the published 9/11 Commission report, thereby continuing in position the same people and the same culture that has made possible a series of successful terrorist attacks. Expect further successful terrorist attacks to be made possible by these conditions and the culture of cover-up in the United States.
- I have been in constant contact with that mole, along with a former FBI agent and highly decorated Vietnam Lt. Col., that worked under that FBI supervisor. The information and evidence that they provided to me, combined with what I discovered of misconduct of DOJ personnel starting from when I was a government agent, makes clear that a serious national security problem exists in that government department.
- The source of my knowledge about the advance information of several major terrorist attacks that was covered up by high-level Department of Justice personnel included that mole in the al Qaeda cell, and a highly decorated Vietnam helicopter pilot and Lt. Colonel that was an FBI agent working with that FBI supervisor involved in the murders, and government documents that they provided to me. In addition, I acquired over the years a great amount of information on criminal conduct by

FBI-DOJ personnel.

- Additional relevant information to the problem of terrorist attacks includes the downing of Pan American Flight 103, details of which I placed in my not-for-profit book, *Unfriendly Skies: 20th & 21st Centuries*. That information included FBI personnel (a) purchasing the alleged timer that exploded the bomb, and was planted miles from the accident scene six months after the bombing; (b) bribing the seller of that timer to testify falsely; (c) bribing a shopkeeper to falsely testify; (d) threatening other witnesses whose truthful testimony would have exposed the conduct by the FBI agents; (e) covering up for the actual bombers that resided in Syria so as to obtain Syria's cooperation in the first U.S. war against Iraq; and (f) charging an innocent Libyan with the bombing and deaths of 270 people. With that misconduct and culture the stage for subsequent terrorist bombings, including the withholding of information so as to protect a serial murderer in the FBI.
- Among other misconduct (i.e., criminal obstruction of justice and criminal retaliation against a witness and former federal agent) by FBI-DOJ personnel were the attacks upon me (and other present and former government agents) to silence my efforts to report the corruption that I discovered during my professional and official duties within the FAA, related to a series of earlier aviation disasters.
- The above areas of misconduct constituting crimes against the United States and its people are only a portion of what we, collectively, discovered during the past half century during our professional and official duties. Additional information can be found at the following locations:

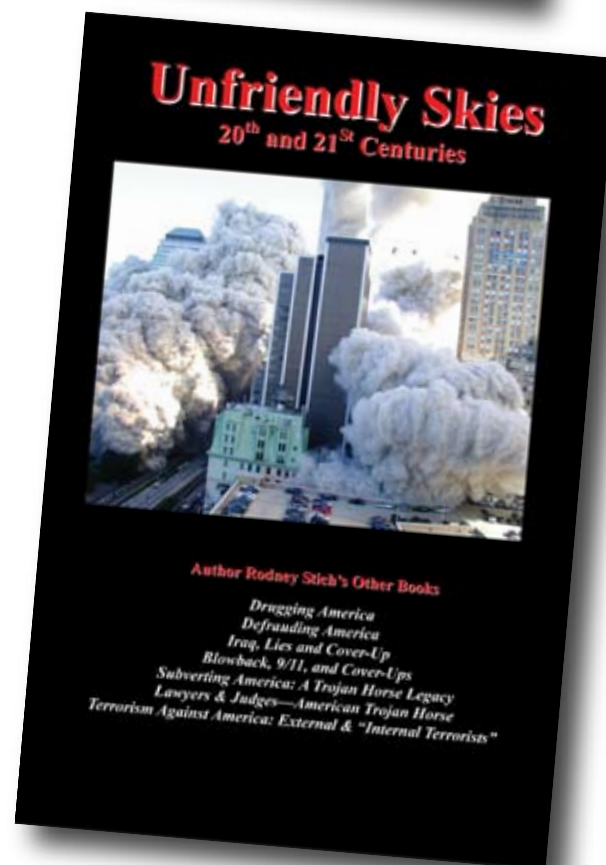
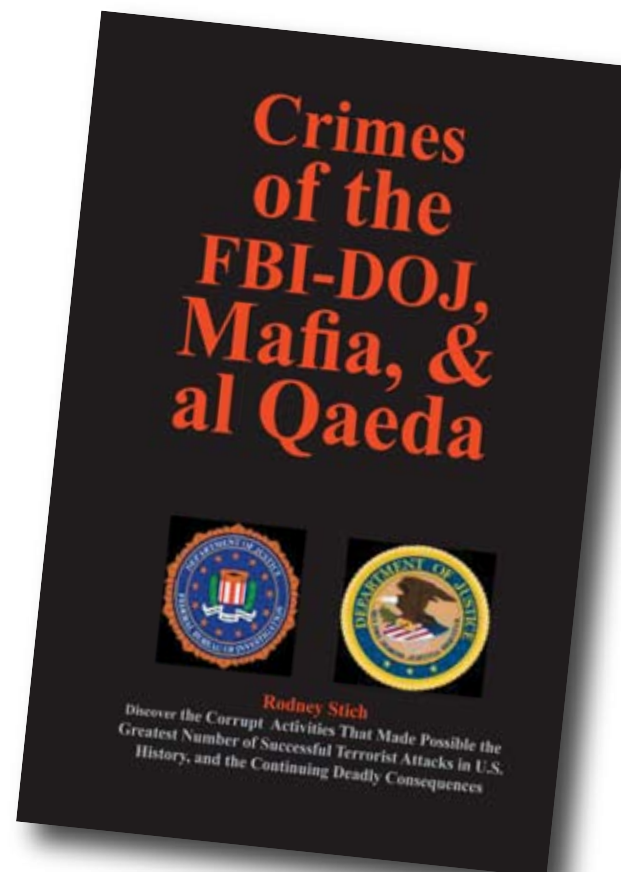
Most Complete Insider's View of Why Terrorist Attacks Against U.S. Have Succeeded
