Ref: Appearance of Justice Kennedy before your committee, and, surprise: 911!

To Senators Specter and Leahy:

I am prompted to send this letter because of the recent appearance of Justice Anthony Kennedy before your committee. Also, it provides me *another* opportunity to put you on notice of serious problems in the federal judiciary and the adverse ripple effects of these problems on the United States.

As to my credibility, I am a former federal aviation safety inspector-investigator, a former airline captain, and a former Navy patrol plane commander in World War II. I have written several books on government intrigue, and have appeared as guest and expert on over 3,000 radio and television shows since 1978.

As a government agent, I discovered a culture of corruption that was preventing the federal government from performing its responsibilities. The results were an endless series of airline disasters and deaths. This is the culture that created the conditions enabling terrorists to hijack four airliners on 9/11. It is also the area of primary blame that the 9/11 Commission carefully avoided.

Because of the history of congressional cover-ups of these problems, and because of the gravity of the resulting tragedies, I engaged in various efforts seeking to expose and force attention to these matters. As a government agent, I used the law in such a manner that I acted as an independent prosecutor and conducted hearings that lasted about four months. I then left government and sought to attack the problems as a private citizen. These included publishing books and appearing as guest and expert on hundreds of radio and television shows since 1978, totaling over 3,000 at this date.

Seeking to force attention to be focused on these serious matters, I used the federal crime reporting statute to circumvent the standard blocks in the federal government. This is where Justice Anthony Kennedy entered the picture, starting while he was a judge in the Court of Appeals in San Francisco.

I filed federal lawsuits under the federal crime reporting statute<sup>1</sup> to report the criminal activities that I and my large numbers of other former government agents had discovered. Under that criminal statute, federal judge *must receive* information of a federal crime as part of their *administrative* duties. Instead of meeting their responsibilities, this is how federal judges responded, and this included Judge Anthony Kennedy:

- In *every* instance, federal judges (and Justice Department lawyers) blocked me from making the reports, thereby obstructing justice. These were criminal acts that protected the guilty and continued the federal crimes and the resulting consequences of such crimes. In two of my books,

*Unfriendly Skies: 20<sup>th</sup> & 21<sup>st</sup> Centuries*, and *Blowback, 9/11, and Cover-Ups*, I show how these judicial tactics continued the corrupt conditions in the FAA, and to a lesser extent, the FBI and CIA, enabling the conditions to continue that enabled terrorists to hijack four airliners on September 11, 2001, and kill 3,000 people.

- To halt my attempts to report these crimes, federal judges issued a series of unlawful and unconstitutional orders permanently barring me from filing any papers in federal courts. These orders still exist today, which converted me, as it relates to the protections of the laws and Constitution of the United States, into a man without a country. They were additional tactics that obstructed justice with dire consequences for the people of the United States.
- The judicial orders and conduct blocked me from reporting the corrupt activities that had already resulted in years of preventable airline disasters, and blocked me from exercising federal defenses against the continuing series of legal attacks that were major violations of federally protected rights, and were parallel efforts to silence me. Over 50 lawyers, law firms, and federal judges have been involved in parallel obstruction of justice tactics to prevent this information from reaching the public.
- Federal judges also misused the federal courts to retaliate against me for reporting additional federal crimes to a federal judge. Also, for exercising federal defenses against the continuing massive violations of federally protected rights. In 1987, federal judges sentenced me to six months in federal prison on criminal contempt of court charges (for attempting to report the criminal activities). At the age of 67, and shortly after undergoing an operation for multiple coronary bypasses, I was sent to federal prison under abnormally harsh conditions, and spent two months in solitary confinement.
- I submitted to Judge Anthony Kennedy, while he was still at San Francisco waiting to take his position as a justice on the U.S. Supreme Court, an emergency petition to halt my imprisonment, listing the criminal activities I and my group sought to report, and listing the obstruction of justice and the retaliatory actions taken by federal judges to silence me.
- These were extremely serious matters affecting major national interests. What I was bringing to his attention included not only (a) the criminal activities in key government offices (some of it occurring in the Ninth Circuit); (b) the obstruction of justice by federal judges, which were federal crimes; (c) the judicial retaliation for attempting to report these criminal activities and judicial retaliation for exercising federal defenses against the parallel unlawful and unconstitutional actions taken to silence me, also criminal acts; and (d) conduct in the federal courts that met the legal definition of a criminal racketeering enterprise under RICO. Kennedy had a responsibility under federal criminal statutes to intervene. Instead, he misused his judicial position to aid and abet the offenses, which continued the catastrophic events that followed.
- Compounding all this, while I was in prison, federal judges rendered unlawful and unconstitutional orders seizing and liquidating the \$10 million in assets that funded my exposure activities. When I filed objection to the seizure, I was *again* charged with criminal contempt of court for filing the objection. From 1987 to 1995, I was continually under criminal contempt of court charges or in prison on those charges. I was eventually converted from a multi-millionaire to a state of poverty.
- After Kennedy became a Justice of the U.S. Supreme Court, I continued to make him aware of the ongoing judicial corruption through letters and petitions for writ of certiorari that I submitted to the Justices. By then, the gravity of the judicial corruption was so severe that the decision was apparently made to continue the prior cover-ups. This was made even more important after terrorists hijacked four airliners on 9/11, which were made possible by the corrupt activities in the FAA (that blocked the implementation of the known preventative measures) and the corrupt activities in the FBI and CIA that blocked actions being taken against the evidence of the

hijacking scheme.

Obviously, these are serious charges that require more than the usual cover-up by members of Congress. At the Internet site, [www.defraudingamerica.com](http://www.defraudingamerica.com), I list some of the corruption and consequences in the aviation environment, and the role played by this culture in the threats now facing the United States. This letter will be placed at the site, and people will be encouraged to inquire why you have not done anything significant to openly investigate the matter

One way to look at the conduct of Justice Anthony Kennedy is to consider the horror of men and women jumping to their deaths from the World Trade Center on September 11, 2001, and then flash back to his complicity in blocking the reports of the federal crimes that I and a group of other former government agents sought to report, only to suffer severe criminal retaliation by a group of federal judges, including Judge and Justice Anthony Kennedy (and for that matter, the remaining Justices of the Supreme Court that became complicit in these offenses.

Several of the below-named senators were made aware of these serious problems years ago, insuring that this committee will continue the standard congressional cover-up!
